Safe Return to School and Continuity of Services Plan

Updated: August 9, 2021

Shelby Public School District will continually monitor guidance from the CDC, the Governor's office of the State of Montana, and the Toole County Health Department. Currently, Toole County has an active case number in the mid-twenties.

Historical Perspective Regarding the Shelby Reopening Process

March 2020 - June 2021

1. The Shelby Public School District was ordered to close to in person instruction on March 15, 2020, under an executive order issued by then Governor Bullock. Districts were provided a two-week period of time during which they could remain fully closed to instruction of any kind while developing a plan for remote instruction required by the Governor.
 - a. Shelby School District remained closed as authorized until March 30, 2020, at which point our district reopened pursuant to a reopening plan approved by the Governor.
2. On April 22, 2020, then-Governor Bullock lifted his Stay at Home Order, and Announced a Plan to Begin Phased Reopening of Montana. As part of that plan, effective May 7, 2020, all schools were provided the option to return to in-class teaching at the discretion of local school boards.
 - a. Shelby Public School District finished the 2020-21 school year through remote instruction. During the 2020-21 school year, our means of operation have included:
 - i. In-person Instruction
 - ii. Distance Learning
3. Our district developed a plan for reopening to in-person instruction, with contingencies, and we implemented that plan for the 2020-21 school year. The reopening plan, details regarding which are provided below
4. Our district is finishing the 2020-21 school year strong, having provided high quality learning opportunities to the students in our community in safe and effective learning environments.
5. We embraced a fundamental principle of providing extensive transparency to our community throughout the above timeframe. We publicly noticed, held meetings regarding, and provided extensive opportunities for our community to provide us with feedback regarding the School District's plans and we carefully considered such feedback in developing and refining the School District's plans throughout the last 14-15 months.

2021-2022 Planned Reopening Expectations

School District Meetings, Events, and Visitors

The Shelby Public School District has adopted the protocols and procedures in this document to govern actions for the duration of the declared public health emergency to ensure the safety of staff and students. Administrators, teachers and other Shelby employees are authorized to implement the procedures in coordination with state and local health officials.

At this time, all meetings and events may proceed without restriction.

Visitors and Volunteers

Visitors and volunteers will be permitted with permission from the school principal or the superintendent.

School Board Meetings

School Board Meetings will be held in person without restriction.

Health and Safety

Health Checks

Parents are responsible for ensuring their child does not have a temperature prior to arrival at the bus stop or school. Students whose temperature registers above 100 degrees should be kept at home. Students demonstrating signs of illness will be evaluated and sent home pending that evaluation.

Symptoms of Illness

Students and staff who are ill, feeling ill, diagnosed as ill, and/or otherwise demonstrating symptoms of illness must not come to school or work. Students who have a fever or are exhibiting other signs of illness must be isolated in a designated area until such time as parents or caregivers may arrive at the school to retrieve the ill student. All surfaces and areas should be thoroughly cleaned and disinfected once the student has vacated the area by staff.

Physical Distancing

Physical distancing will be observed when appropriate.

Lunch Program

School lunch will be served in person without restriction unless we have an in school surge of COVID-19 cases.

Face Coverings

Face coverings will be optional for all staff, students, and visitors unless we have an in school surge of COVID-19 cases.

Busing

Students and bus drivers must wear a mask on school buses at all times per Federal Law and CDC guidance.

A driver does not need to wear a mask if they are the only person on the bus.

Transitions and Lockers

There will be no restrictions on transition time or at student lockers unless we have an in school surge of COVID-19 cases.

Cleaning, Sanitation, and Ventilation

There will be no restrictions on maintenance or custodial duties unless we have an in school surge of COVID-19 cases.

Academic

There will be no restrictions on academic instruction unless we have an in school surge of COVID-19 cases.

Distance Learning

Shelby Public School District will establish an online educational platform for students with special circumstances. Edgenuity will be the online platform used for students in grades 5-12 for FY22.

Rubric for Opening Shelby Public Schools

This guidance document serves as a framework for opening Shelby Schools in a healthy and safe manner, relative to the phase or level of COVID-19 spread we are experiencing at the state and local level. The components of this plan will remain flexible and adaptable to the potential changes within each step. Therefore, this document will be updated regularly as new information becomes available and/or additional requirements are requested of the Shelby Schools.
